 - Produced The Mosaic Guide community resources specifically designed for ESL citizens
 - Formed culturally diverse student advisory group for ATOD usage prevention [GRAAB]
 - Funded diverse student group to attend CADCA conference for two years in DC
 - Hired a Inspiring Tomorrow's Leaders Today [ITLT] Director to promote leadership skills among our most diverse middle and high school populations
 - Printed an anti-drug brochure in Spanish

Evaluation

- Formed an evaluation team consisting of three college professors, Project Director, and community organizer
- Held monthly meetings to discuss SSHS project implementation activities, to review data collection process and to forecast outcomes effectiveness
- Designated one evaluation team member to conduct regular on-site visits with each partner
- Designed, administered, and evaluated three annual School Climate Surveys with comparative three-year trend data
- Presented three-year data to both school administrative groups
- Referred to the School Climate Survey data in the weekly newspaper column written by the SSHS Project Director

Evaluation

- Required campus administrators to use this school climate data in their respective School Leadership Teams working on the School Improvement Plans
- Conducting a study of the outcome effectiveness of Life Skills with middle schools using pre and post test data
- Established GRPA measures and reported three-year data on each of these measures to NET and local school administrators
- Presented evaluation data to partners to support changes needed to address Initiative goals
- Purchased a scanner and printed scan sheets for the two districts to continue the annual administration and evaluation of the School Climate Survey
- Designed and used the Logic Model for evaluation monitoring

Finance

- Hired our own SSHS Bookkeeper/Human Resources Director
- Used Quick Books software for all financial records
- Produced monthly financial reports in an Excel spreadsheet format showing the percentage of funds expended, each partner's allocation, expenditure amount and percentage and amount of federal draw downs
- Compiled a series of personnel forms for leave time and travel consistent with the fiscal agent's policies
- Presented our financial records keeping systems at a SSHS conference for 2008 Project Directors and school district budget managers
- Had two successful "no-find" audits of our financial records
- Sought additional grant funding for partners by writing and assisted in writing future grants
- Completed contracts for each partner with specific requirements regarding financial records and an attached annual budget
- Partners know that invoices are due the 20th of each month with attached receipts

- Implementation of Programs/Activities
 - Second Step training has now occurred in all elementary schools
 - Life Skills is taught to all city middle school students and 7th & 8th graders at a county middle school
 - Created a system of care for helping students whose social/emotional problems mitigate against academic achievement
 - A referral process for students with behavioral problems or mental health issues is in place and observations and followup is done by Learning Support Specialists [LSS] in each district
 - A team of mental health counselors offers free in-school counseling to students referred from the LSS
 - Updated District Safety Plans are now available in secure online versions
 - Each school has a School Safety Team trained on how to conduct Security and Vulnerability Assessments

- Implementation of Programs/Activities
 - Behavioral Assistants work with pre-school teachers in dealing with disruptive pre-schoolers and identify those students/families who need further counseling
 - Anger management classes are now offered to pre-k
 12 students through a SSHS partner
 - An anti-underage drinking organization [AUDIO-C], a spin off of SSHS, presents programs regularly in all middle and high schools
 - An ATOD usage prevention coalition, Going Respectfully Against Addictive Behavior [GRAAB] another spinoff of SSHS, has strong student participation and a middle school student recommended the title for the organization

Leadership

- Through discussions with the SSHS Project Director, the entire Juvenile Justice Department has changed its operation from a punitive model to one based on prevention/intervention
- SSHS Project Director is linked closely with all Board of Education members, two Directors of Schools, city and county governmental officials and actively participates in the political and governmental process
- All partners are issued contracts annually which include specific requirements regarding data collection and submission and federal report deadlines; annual budgets are attached to each contract

- Management and Governance
 - Monthly partners' meetings keep all partners aware of the Initiative's implementation and management structure
 - Staff decisions are made collaboratively and with input from the evaluation team based on quantitative data
 - Partners express their concerns directly to the on-site evaluator and/or to the Project Director
 - Issues or concerns are addressed within the same day by the Project Director through e-mail

Partnerships

- Three SSHS partners [YMCA, Boys' & Girls' Club, and Bradley Initiative for Church and Community] jointly fund a Mentoring Coordinator to work with most economically disadvantaged youth
- A partner, Bradley/Cleveland Rehab Services, has joined forces with the two districts and LSS and through SSHS funding, established a Youth Counseling Center providing free counseling; future funding will be come from a phased-in third party reimbursement
- Clear expectations for all partners to work together and to attend monthly partners' meetings were initiated at the beginning of the project and listed on their annual contract
- Various partners have had responsibility for presenting topics at the monthly meetings

Partnerships

- Partners have collaborated on numerous community events at various locations
- From the beginning, the Logic Model was presented to partners taking one Element at a time and looking at the specific goals, objectives, activities, and GPRA measures associated with each
- At every Partners' Meeting, there is a Powerpoint presentation which lists various activities sponsored by the respective partners

Policy

- SSHS Initiative goals were discussed with both school district administrators and alignment with their School Improvement Plans were made
- Detailed minutes of all Partner's Meetings are kept and distributed to each partner
- All partners understand the policies and procedures for submitting annual budget requests

- Strategic Planning
 - From the beginning, the project was always referred to as an INITIATIVE and NOT a grant!
 - A specific retreat was held during FY2 which was attended by 56 people including partners, Board of Education members, and local elected officials to draft a Strategic Plan document with a timeline that carries the activities forward through 2011
 - A sequel organization, called Community Action
 Network [CAN], was introduced at the SSHS Legacy
 Luncheon held at the end of FY3
 - New organization will operate with the SSHS partners funded during FY4 and other community organizations under the direction of the United Way

Strategic Planning

- Strategic plan retreat was facilitated by an external facilitator with a guest speaker [Knoxville Mayor] who shared a vision of community collaboration for problem solving
- Individual spokes of the Legacy Wheel were presented at monthly Partners' Meetings with discussion as to how each partner could contribute to sustainability
- SSHS Project Director routinely notified and assisted partners of additional funding sources
