Assessment

- Focus Groups with teens in AEP
- Anecdotal reports from Core Management Team
- Largely the schools were ignoring or covering up the issue
- Issue at local high school

JSCT's Assignment

- Define the problem(s).
- Define the ages of the kids we need to reach.
- Decide which problem to focus on first.
- Develop and test the messages.
- Determine internal system changes that need to begin.
- Determine if the messages are working.


The Big Three

- Students under 10 years old acting out sexually at school
- “Consensual” sex among teens
- Sexting

Process

- JSCT met several times over 2 month period.
- Team developed the initial message “Once you post, there’s no delete.”
- Tested message with a focus group of teens in the juvenile detention center.
- Modified the media. (Brochure example)

As a Result . . .

- Arrest made

Changes at District

- Student Code of Conduct under “Mistreatment of Others”
 - Bullying
 - Sexual harrassment
 - Inappropriate exposure
 - Pornographic materials

School Discipline

- DAEP
- ISS
- Placed in a different school

Policy and Procedure

- Teacher who sees image turns phone/computer over to principal. We need reasonable suspicion to search.
- Teacher tries to report where image is located so we **only** search the portion of the phone that is suspected. (Photos, text messages, email)

Policy and Procedure

- Principal decides if image is inappropriate or illegal.
- If in doubt, err on the side of caution by letting the police decide.

District Attorney's View

- “If what is happening in the photo would be illegal if it was happening in person, then it is illegal.” Primarily they are looking for sexual acts.
- Don't get your feelings hurt if no charges result. Police will look into charges ranging from harassment to distribution of child pornography.
