


Health Hot Spots Mapping Project





Categories of Violence:


1: No violence exposure reported


2: Exposure to threats of violence

4: Exposure to beatings, leading to serious injury


5: Exposure to violence involving knives or guns






Los Angeles County Medically Underserved Areas (MUA)




Los Angeles County Department of Health Services Facilities

Plan to address Health Status Disparities

- The Los Angeles Trust for Children's Health, (a district-affiliated organization established by the Board of Education in 1991) convened several cross sector health experts in Los Angeles to develop a set of **Priority Recommendations** aimed to improve student health status.
- Bond monies that support the facilities have specific earmarks for joint-used projects.
 Joint-use projects include agreements and partnerships with external agencies to utilize the school facility in a joint cooperative arrangement which brings greater benefit to the school, students and members of the community.
- Mobil Health Care Initiative: At the end of this initiative, staff plans to equip over 250 school sites with infrastructure to accommodate mobile health clinics in the highest need communities and triple the District's mobile health clinic capacity.
- School Based Health Centers: (Wellness Center): with the expansion of health services, uninsured and underinsured students in LAUSD will have access to additional services, such as: expanded nutrition counseling(individual & group); expanded healthcare enrollment for students and families; increase mental heath services; increase primary care service hours; reproductive health counseling and services; and the establishment of after-school program like, internships, and fitness programs.

Public Access Stations

PROJECT OVERVIEW

On January 2009 The Center to Promote Health Care
Access and Los Angeles Unified School District received
a three-year-grant from Kaiser Permanente Community
Benefits Program to enhance the current web-based
One-e-App system and develop "Kiosk/public access
stations" at strategic locations within the LAUSD. Using
On-e-APP families are able to enroll their children and
themselves into public health and social service
programs in Los Angeles County.

LAUSD One-e-App System Cont.

- Social service programs include:
- Food Stamps,
- CALWORKS
- Woman, Infants and Children Nutrition Program (WIC),
- And referrals to Earned Income Tax Credit (EITC), California Alternate Rates for Energy (CARE) and Low-Income Auto Insurance Program.

PUBLIC ACCESS STATIONS (PASs)

- Computer systems set up at selected LAUSD school, partner sites and WIN Center
- Each station consists of a computer, printer, fax/scanner and telephone.
- Each PASs site will have a "Site Facilitator" who is preferably, a Certified Application. Assistant (CAA) and has also been trained in One-e-App. The main role of the Site Facilitator is that of support to a family initiating their application online and service promotion.
- A "Health Care Advocate" will be assigned to the PASs site to provide face-to-face assistance. To assist families with screening process, case management and trouble shooting.

Children's Health Access and Medi-Cal Program (CHAMP)

 The Children's Health Access and Medi-Cal Program (CHAMP) is an LAUSD program which assists more than 5,000 families annually in determining if they qualify for health insurance programs like Medi-Cal and Healthy Families. In addition, CHAMP uniquely qualified to help families obtain other social service programs like WIC, Food Stamps, CAL WORKS, Low-Cost Auto Insurance, and many other free or low-cost insurance.

CHAMP Cont.

- Families have the option to choose their preferred method to apply for the above mentioned programs by:
- APPLY ONLINE: Parents are able to self-enroll through KIOSK site, LAUSD/CHAMP Website over any Internet Connection
- APPLY IN PERSON: If families prefer face-to-face assistance, then families may visit one of 11 LAUSD's Public Access Stations (PASs). Each location has staff to assist families if needed when applying.
- APPLY OVER THE PHONE: Families may call the CHAMP Office where trained staff can assist 7:30a.m. to 3:00p.m. Monday through Friday.. CHAMP staff will take information over the phone, keep it confidental, gather required documents from you, and submit your materials for you.
